***PROCEEDINGS OF THE 32nd MEETING OF THE ACADEMIC COUNCIL HELD
IN THE ACADEMIC COUNCIL HALL OF THE UNIVERSITY ON 30-11-2016***

MEMBERS PRESENT:

Dr. V.D.Patil, Registrar and Member-Secretary welcomed the members and presented the attainments / activities of the University for the period from 1st August 2016 to 29th November 2016.

Hon. Vice-Chancellor briefed the members with the following information:

- In this meeting, apart from taking up the Agenda Items, feed-back from the distinguished members of the Academic Council was sought for further excellence in the functioning of the University.
- Shri Narendra Modiji, Hon. Prime Minister of India graced the function organized on the eve of the centenary celebrations of the KLE Society at District Stadium, Belagavi on 13th November 2016. He was very appreciative of the contribution made by the KLE Society in general and the sacrifices made by seven teachers 'Saptarshis' who had founded the KLE Society in particular. He took promise / assurance from the KLE faculty and students to fulfill the following three targets / assignments within next five years:
 - To become one among the top 100 Universities in the world. Hon. Prime Minister assured that the Government will extend all necessary support including financial grant to the Universities including Private Universities who show zeal and enthusiasm to compete to become one among the top 100 Universities in the world.
 - To carry out quality research and develop at least one innovative practice which will be recognized world over.
 - To encourage the students to actively participate in sports and expected that at least one student from KLE Institutions will get a medal in the Olympics-2020 to be held in Tokyo (Japan) in 2020.

With these promises having given by all the faculty and the students in the presence of Hon. Chancellor to Hon. Prime Minister of India, we are duty bound to work in that direction, with utmost determination.

Based on the commitment made by the KLE faculty and students and the assurances given to Hon. Prime Minister, the KLE University has taken initiation to work out plan of action / strategies to fulfill these promises made from our side.

- The University shall establish KLE Academy of Sports and also frame Sports Policy to encourage and groom the students for participating at national and international levels. The University shall constitute a Committee for the same.
- The Hospitals attached to the respective constituent units have data collected from the patients on various investigations which may be utilized for conduct of research activities and publications. While publishing the research articles in the journals, the faculty members shall ensure that the name of the University / Institution is mentioned in such articles. There is a need to develop electronic data-base by the respective Departments.
- The University shall constitute a Committee for compilation of the information as regards to the research publications by the faculty members so that the research output is very well projected.
- The KLES Dr. Prabhakar Kore Hospital and MRC and KLE Shri B.M.Kankanawadi Ayurveda Mahavidyalaya have been accredited by NABL and NABH respectively. MD & CE, KLE Dr. Prabhakar Kore Hospital & MRC informed that the NABH officials are visiting the Hospital on 15th December 2016 for inspection. In the meantime, the Hospital has already complied with the suggestions made by NABH on certain aspects. All the faculty / staff members have to extend their full support and co-operation and provide the required information on top priority to the Hospital to facilitate successful conduct of the inspection.
- The constituent units / departments shall give more importance for proper maintenance of records.
- As a part of the centenary celebrations of the KLE Society, J.N.Medical College and KLE VK Institute of Dental Sciences have conducted mega health check-up camps for the benefit of the public at large and dental check-up camps mainly for the benefit of school children covering a population of more 1.30 lakh in medical and 1.03 lakh in dental check-ups. This by any standard should be a world record involving such a huge community health work benefiting more than a lakh of population including children. This needs to be properly documented and presented in the format to be submitted to world record authorities like Guinness Records / Limca Book of World Records. This requires professional approach. A Committee consisting of the following members shall process the data and submit the required information:
