IN THE ACADEMIC COUNCIL HALL OF THE UNIVERSITY ON 21-04-2017***

**MEMBERS PRESENT:**

Dr. V.D.Patil, Registrar and Member-Secretary welcomed the members and presented the attainments / activities of the University for the period from 1<sup>st</sup> December 2016 to 20<sup>th</sup> April 2017.

Hon. Vice-Chancellor briefed the members with the following information:

- The faculty members who intend to publish research articles shall invariably mention the name of the University as **KLE Academy of Higher Education and Research (KLE University)** and the **concerned Institution** so as to project / reflect the achievements of the University as a whole.
- The Principals of the constituent units / Heads of the Departments shall ensure that the information sought by the University is furnished on top priority without giving scope for any reminders.
- The faculty members need to give more impetus for patents which is considered as the highest parameter while ranking of the institutions by the ranking agencies like NIRF, K-SURF, etc.
- As a part of e-governance and paperless administration, the Principals / Heads of the institutions / Departments shall henceforth correspond through e-mail only.
- The Principals of the constituent units / Heads of the Departments shall ensure that appropriate action is taken based on the feedback received from the students / alumni members / stakeholders as regards to curriculum aspects / examination reforms / innovative practices, etc., after detailed deliberations and resolutions adopted in the meetings of the respective Boards of Studies and keeping in view the norms of the respective Regulating Councils / UGC.
- The information as regards to alumni activities needs to be disseminated on the University website with updation of details from time to time.
- The Principals of the constituent units / Heads of the Departments shall analyze the parameters of the Ranking Agencies (NAAC / NIRF / K-SURF / NABH, etc. wherein we need to improve so that the KLE University / its constituent units will be able to get better ranking next time. All the faculty and staff members need to put their sincere efforts to ensure that the KLE University will be one among the top 50 Universities in India.

- The Principals of the constituent units shall ensure that campus interviews are conducted every year particularly for the students who complete their Under-Graduate / Post-Graduate degrees in pharmacy, ayurveda, physiotherapy and nursing sciences. The relevant details / documents of the students who undergo higher studies / get employment in institutions / organizations / companies be kept in the respective institutions. The University will appoint Officer Incharge of the Employment and Career Guidance who shall co-ordinate with the respective institutions in this regard.
- The University, with a view to ensure effective monitoring of the allied courses, shall consider appointment of teaching faculty on full-time basis for core subjects for the Department of Allied Health Sciences.
- The Principals of the constituent units shall submit the details of the reputed Journals - Department-wise / Specialty-wise Journals (reputed / indexed) so as to forward the same to the UGC.

Dr. M.S.Ganachari, Deputy Registrar made presentation of the details of the parameters which were considered by the NIRF / K-SURF for ranking of the KLE University for the benefit of the members.

Dr. H.B.Rajashekhar, distinguished member informed that the University attained unique achievements in academics, research, administration, etc. with highest level accreditations by NAAC, MHRD (Government of India), UGC, K-SURF, NIRF, etc. under the able leadership of Prof. C.K.Kokate, Hon. Vice-Chancellor who gave valuable guidance and co-operation to all the faculty and staff members during the last eleven years.
