RECOMMENDATIONS OF THE BOARD OF EXAMINATIONS MEETING HELD ON 06-03-2018 AND APPROVED BY THE ACADEMIC COUNCIL MEETING HELD on 28-03-2018

The recommendations of the Board of Examinations meeting held on 6th March 2018 were placed in the meeting of the Academic Council held on 28th March 2018. After detailed deliberations, approval has been accorded to the following proposals:

1. Consideration of merging of MBBS Phase-I supplementary (old batch) examinations and instantaneous examinations of KAHER.

As per the existing pattern of examination, at present there are three examinations conducted yearly from 2015 batch onwards as detailed below:

MBBS Phase-I - Regular Examination

MBBS Phase-I – Instantaneous Examination (within 60 days) after results

MBBS Phase-I – Supplementary Examination (for old course students)

After detailed deliberations, the proposal for merger of two examinations viz. Instantaneous examinations for MBBS Phase-I (within 60 days) after results and MBBS Phase-I Supplementary Examination (for old course) was approved. With this, henceforth, there will be 'NO' supplementary examinations for old course and the same will be merged with instantaneous examination.

2. Consideration of merging of examinations of old and revised regulations in other courses (other than medical stream)

As per the existing norms of KAHER, it has been conducting examinations for various academic programs / courses (other than medical stream), keeping in view the norms of the Old Regulations, Revised Syllabus and Revised Syllabus-2 separately.

After detailed deliberations, it was resolved to conduct old course and new course examinations (where the syllabus is same) together with same set of question papers and on same days.
