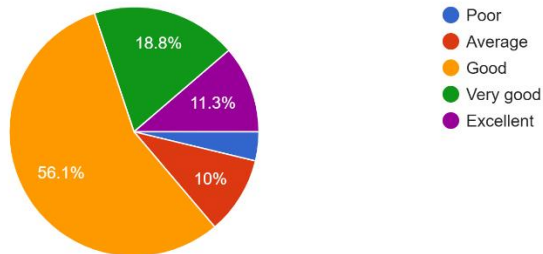

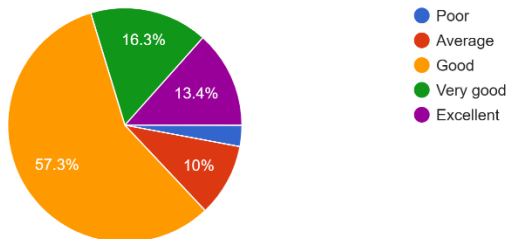
1. Rate the course curriculum for which your ward has been enrolled?

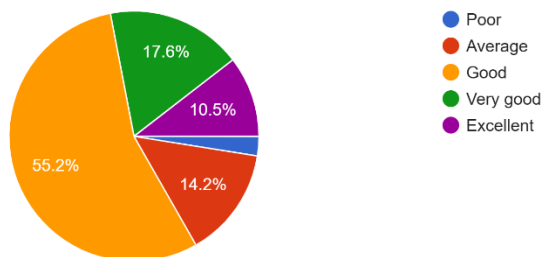
2. Rate the quality of teaching in the institute

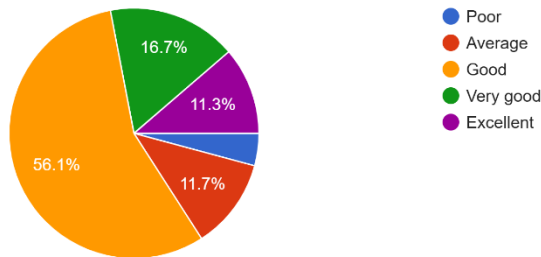

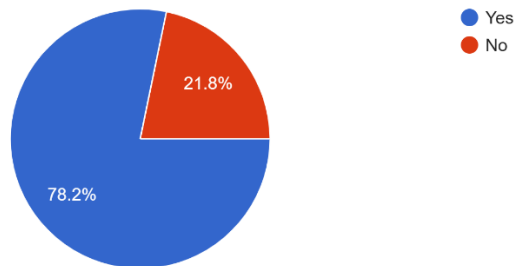

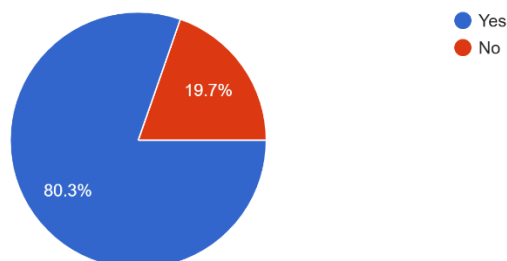
5. Are you aware of mentorship program in the institute?

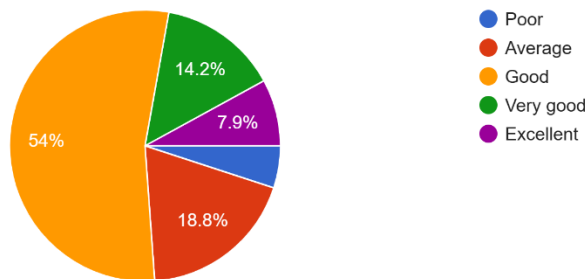

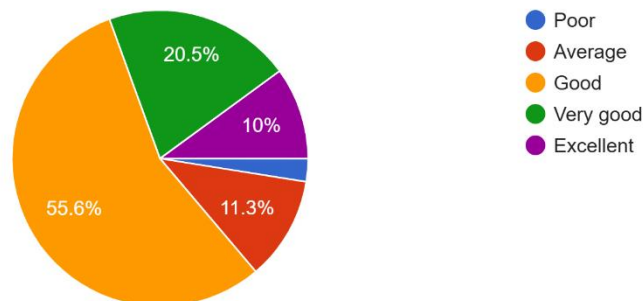
7. Rate the ease of your communicability with, a. Administration office

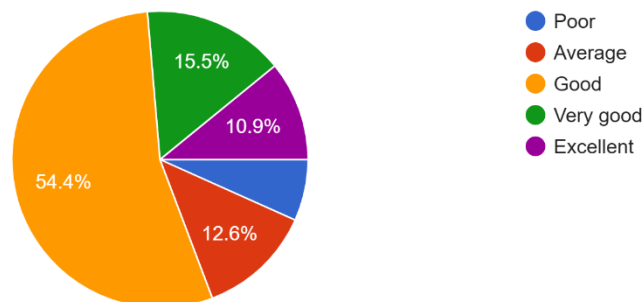
7. Rate the ease of your communicability with, b. Teachers

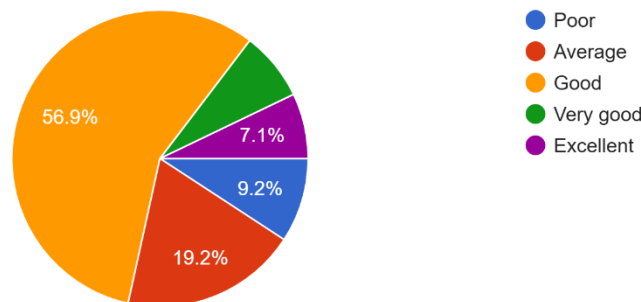

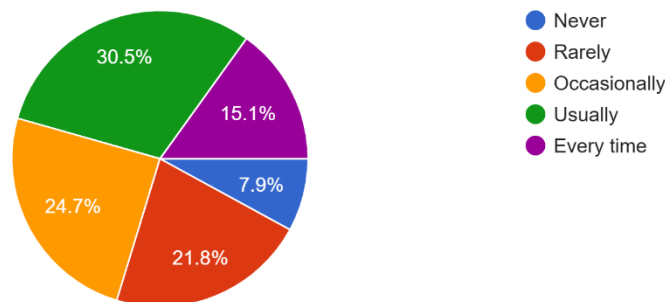
7. Rate the ease of your communicability with, d. Hostel facility
